

Supplier Diversity Policy

Generac Power Systems Inc. is invested in building inclusive relationships in the communities in which we operate. As a diverse organization, we recognize the importance of having a supply base that reflects the diversity of our customer base. Our Supplier Diversity Program's mission is to proactively engage and build partnerships with diverse suppliers of goods and/or services. Definition of Diverse Suppliers

Diverse suppliers are businesses that are at least 51% owned, controlled, and operated by individuals who belong to groups that have been historically underrepresented in the marketplace. These groups may include women, minorities, veterans, LGBTQ+, and individuals with disabilities.

Goals and Objectives

Our goal is to promote the inclusion of diverse suppliers in our procurement process. We recognize that this can benefit our company in several ways, including:

- Encourage innovation, creativity, and competition,
- Providing access to a wider range of products and services,
- Building stronger relationships within the communities we serve.
- Promoting economic development in underrepresented communities, and,
- Supporting corporate social responsibility initiatives.

To achieve this goal, we will:

- Develop and maintain a diverse supplier database to track the utilization of diverse suppliers within key parts of our business,
- Provide education and training to our procurement team on the importance of supplier diversity and how to identify and evaluate diverse suppliers,
- Work to develop a process to monitor the percentage of our spend that will be allocated to diverse suppliers, and,
- Commit to continuous improvement.

Supplier Diversity Program

We will actively consider diverse suppliers in our procurement process. This includes:

- Implementing processes to help ensure that procurement opportunities are made available to diverse suppliers.
- Encouraging diverse suppliers to register with us,
- Evaluating suppliers on an equal basis using objective criteria, including quality, price, delivery, and customer service, and,
- Providing feedback to all suppliers on their performance in our procurement process.
